
I am directed to forward herewith the application of  
Manager of St. Peter's High School, Hanamkonda, Warangal  
District and to state that this Government have no objec-  
tion to accord affiliation to it subject to the fulfillment  
of the following conditions:

- 1) This State Government reserves the right to withdraw the above certificate at any time, if the management fails to comply with the instructions of the State Government such as illegal removal of teachers, non-payment of salaries to the teaching and non-teaching staff as per the approved scales etc.;
- ii) Admissions should be made with bonafide date of birth certificates;
- iii) All the untrained teachers should be replaced by trained teachers;
- vi) To collect the tuition fee and special fee etc., as prescribed by Government of Andhra Pradesh in G.O.Ms.No.379, Edn., dated 9.8.1985;

- v) Strength in the classes should be increased as per rules;
  - vi) The School management should follow the rules that are in force in Andhra Pradesh State;
  - vii) The District Educational Officer or his nominee should be invited when the management makes recruitment of candidates for various categories of posts;
  - viii) Play facilities <sup>should</sup> to be provided;
  - ix) The management should not collect donations either from students or parents for admissions.
- Staff salaries shd be paid as per Govt scales of Pay.

I submit herewith the proposals in duplicate in respect of St. Peter's High School, Nallagutta, Hanamakonda, Warangal District has been received from Regional Joint Director of School Education, Warangal for according No Objection Certificate for affiliation to C.B.S.E. syllabus from 1989-90.

In this connection, I submit that at present the school is running with State syllabus and enjoying Temporary Recognition upto 87-88 vide D's. proc. Rc.No. 2214/NEP.IV-3/87 dated: 21-12-87 for Classes I to X (Eng. Med).

Further, I wish to state that the management is seeking affiliation to C.B.S.E. course from Class VI to X only. The Management is ~~also~~ given willingness and undertaking to run the Primary Classes I to V in State syllabus and remain in the State syllabus, even after getting affiliation with C.B.S.E. for Classes VI to X.

In view of the above, I request the Government, <sup>Examine</sup> the feasibility to forward the proposals to C.B.S.E. for according affiliation and issue No Objection Certificate subject to the following conditions.

- 1) The school should get permission and upto date recognition for classes I to V from State Education Department.
- 2) The management should follow the state departmental rules and procedure.
- 3) The salaries of the staff should be paid as per Govt. rates.
- 4) The school may also keep ready for any visit/inspection ~~for~~ by the inspecting officers of the State Government as and when required.
